Procedure to Request Digital CD of Proceedings:

- Requesting party completes the CD Request Form.
- Requesting party either takes the completed form to the appropriate Digital Court Reporters' Office, or can mail the form, along with a check or money order made payable to the State of Florida for the \$35.00 CD fee, or a signed Court Order if applicable. **Cash, Debit, and Credit are not accepted.**
- Proceedings digitally recorded in **Putnam County** should be ordered from the **Richard O. Watson Judicial Center Office.**
- Prior to the release of a CD to an individual who is not the attorney of record, a party to the case, or a self-represented litigant, the Digital Court Reporting Office will redact confidential or exempt information from the recording.
- The requesting party makes his/her own arrangements for the production of an official transcript with a private court reporting firm or transcriptionist. Said transcript must comply with requirements set forth in Rule 2.535, Florida Rules of Judicial Administration. Transcription costs will be borne by the requesting party.

Baker Act, Marchman Act, Adult Protective Services Act, and certain Guardianship proceedings, as well as such other proceedings as may be appropriate, are to be made available to parties and/or attorneys of record only.

Juvenile Delinquency proceedings are to be made available to parties and/or attorneys of record upon request, and to others upon Court Order.

Juvenile Dependency, Termination of Parental Rights, Children and Families in Need of Services (CINS/FINS) proceedings, as well as such other proceedings as may be appropriate, are to be made available to parties and/or attorneys of record only, but only if so ordered by the Court.

Parental Notice of Abortion Act proceedings are confidential and may not be made available.
