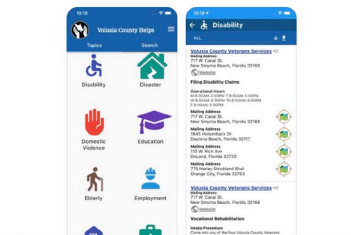

Low-income Home Energy Assistance Program (LIHEAP)

The LIHEAP program provides energy assistance to eligible low-income households to alleviate financial burdens associated with their heating and cooling expenses such as electric, coal, propane and gas.

LIHEAP HOME – Does NOT require past-due notice, disconnection notice, or notice that services have been disconnected.

LIHEAP CRISIS – Requires a past-due notice, disconnection notice, notice that services have already been disconnected, or notice that a deposit is needed to establish services.

Emergency Home Energy Assistance for the Elderly Program (EHEAP)

The EHEAP program provides energy assistance to low-income households that have at least one member who is 60 or older to alleviate financial burdens associated with their heating and cooling expenses such as electric, coal, propane and gas.

Rental and Mortgage Assistance

Indigent Cremation or Burial - Human Services provides limited cremation and burial services to indigent people who pass away in Volusia County in accordance with Florida Statutory requirements.

Family Self-Sufficiency Program (FSSP) - The FSSP program is a voluntary program designed to assist low-risk homeless households to both obtain rental housing and work toward economic self-sufficiency.

Summer Food - Each summer, Human Services operates a Volusia County Summer Food Program in which numerous sites throughout the county provide nutritionally balanced breakfast and/or lunch to children 18 and younger at no cost.

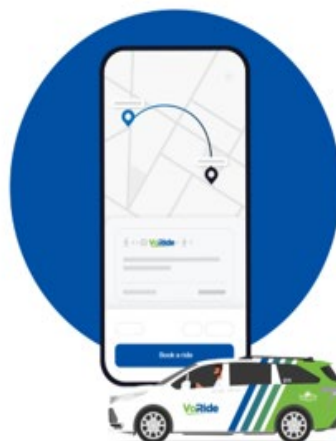

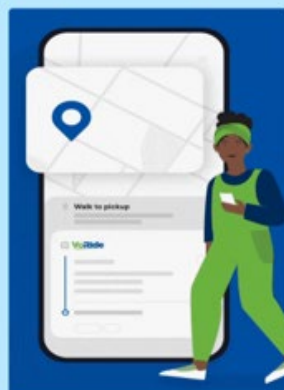


